

Statement Regarding RoHS (Directive 2011/65/EU)

Dear Customer,

This is in response to your recent inquiry for information regarding METTLER TOLEDO products supplied to your company and the Directive 2011/65/EU on the restriction of the use of certain hazardous substances in electrical and electronic equipment, commonly referred to as the RoHS Directive.

To the best of our knowledge, we confirm that METTLER TOLEDO fulfils the requirements under RoHS and that the product(s) listed below are in all material aspects compliant with RoHS.

METTLER TOLEDO undertakes the necessary actions to ensure supply chain continuity. This includes the update of necessary information and the search for alternative processes, materials, and suppliers, as needed, to ensure all products become compliant to applicable amendments by the corresponding deadlines set by the directive.

Note that METTLER TOLEDO products belong to the RoHS category "Monitoring and Control instruments". The Directive 2015/863 amending RoHS with the addition of four phthalates DBP, BBP, DIBP and DEHP to the restriction list applies to METTLER TOLEDO products since July 22, 2021.
